City of Boise Housing and Community Development Division Combined Notice of Public Comment Period and Meeting

2017 Consolidated Annual Performance and Evaluation Report (DRAFT)

The City of Boise, Idaho, invites public comment on the 2017 Consolidated Annual Performance and Evaluation Draft Report (CAPER). The CAPER details how the City of Boise used Community Development Block Grant (CDBG) and HOME Investment Partnerships (HOME) Program funds during Program Year 2017 for activities and accomplishments from October 1, 2017, through September 30, 2018, while addressing community needs and priorities identified in the City of Boise's Five-Year Consolidated Housing and Community Development Plan. The City of Boise's Program Year 2017 CAPER is expected to be submitted to the U.S. Department of Housing and Urban Development on or about December 31, 2018.

The CAPER will be available to the public beginning December 6, 2018. Individuals wishing to receive a copy of the 2017 CAPER may obtain one copy without charge by visiting the City of Boise's Housing and Community Development Division located at 150 North Capitol Boulevard between the hours of 8:00 a.m. and 5:00 p.m. Monday through Friday. The report will also be available on-line at <http://hcd.cityofboise.org/> beginning December 6, 2018. The report can be provided in a format accessible to persons with disabilities and/or persons with limited English proficiency upon request.
